Enforcement

第1条 本会を「武蔵大学国際教養学会（Musashi University Association of Liberal Arts and Sciences）」とよぶ。

Article 1, This association is called Musashi University Association of Liberal Arts and Sciences (hereafter; the Association).

第2条 本会は、会員の研究及びその発表を目的とする。

Article 2, The purpose of the Association is to provide opportunities for research and presentations by its members.

第3条 本会は、前条の目的を達するために次の事業を行う。

Article 3, The Association shall conduct the following activities for the purpose stated above:

(1) 機関誌『武蔵大学国際教養学会論集（Musashi Journal of Liberal Arts and Sciences）』の発行

(1) Publish the Musashi Journal of Liberal Arts and Sciences

(2) 研究会及び講演会の開催等

(2) Hold workshops and lectures

(3) その他適当と認められる事業

(3) Hold other events deemed appropriate

第4条 本会の会員は、次のとおりとする。

Article 4, The members of the Association are as follows:

(1) 普通会員 武蔵大学（以下「本学」という。）国際教養学部専任教員及び国際教養学部学生

(1) Regular members: Full-time faculty members and students of the School of Liberal Arts and Sciences at Musashi University

(2) 賛助会員 本会の趣旨に賛同し、普通会員と同額以上の会費を納入した者。

ただし、評議員会の承認を要する。

(2) Supporting members: Those who agree with the purpose of the Association and have paid membership fee equal to or higher than that of regular members.

However, their membership is subject to the approval of the Executive Council.

(3) 名誉会員 本会に多大の功績があり、評議員会において承認された者

会員は、機関誌の配付を受ける。

(3) Honorary members: Those who have made significant achievements in the Association and have been approved by the Executive Council.

Honorary members receive distribution of Journals.

第5条 本会は、本学学長を名誉会長に推す。

Article 5, The President of Musashi University shall serve as the Honorary Chairperson of the Association.

第6条 本会に会長及び評議員会を置く。

2 会長は本学国際教養学部長をもって充てる。

3 評議員会は評議員をもって構成し、本会の運営にあたり、議長は会長が兼ねる。

4 評議員は、本学国際教養学部教授会構成員をもって充てる。

Article 6, The Association shall have an Executive Council comprised of a Chairperson and other council members.

The chairperson is the Dean of the School of Liberal Arts and Sciences of the University.

The Executive Council shall be formed by members of the Faculty of Liberal Arts and Sciences and chaired by the Chairperson.

The councilor will be assigned to the member of the faculty meeting of the School of Liberal Arts and Sciences of the University.

第7条 本会に編集委員、会計委員及び庶務委員を置き、評議員若干名をもってこれにあてる。

Article 7, Committee memberships in the Association include: 1) the editorial committee; 2) the accounting committee; and 3) the general affairs committee, and a few councilors are assigned to them.

第8条 本会の経費は会費、事業収入、寄附金等をもって充てる。

Article 8, The expenses of the Association will be covered by membership dues, business income, donations, etc.

第9条 普通会員の会費の年額は、次のとおりとする。

Article 9, The annual membership dues for regular members is as follows:

(1) 教授、准教授、講師及び助教 4,000 円

(1) Professor, Associate Professor, Lecturer, Assistant Professor: 4,000 yen

(2) 特任教授 2,500 円

(2) Specially Appointed Professor: 2,500 yen

(3) 学生 2,500 円

(3) Students: 2,500 yen

第10条 本会の会計年度は、4月1日に始まり翌年3月31日に終わる。

Article 10, The fiscal year of the Association begins on April 1st and ends on March 31st of the following year.

第11条 本会の事務局は、武蔵大学研究支援課に置く。

Article 11, The secretariat of the Association is located at Musashi University Research Support Division.

第12条 本会則の変更は評議員会の決議による。

Article 12, Changes to this constitution are due to a resolution of the Executive Council
